The Buffalo Niagara region is located on the western edge of New York State, bordering Canada and Pennsylvania, along the shores of Lake Erie and Lake Ontario. The area is comprised of eight counties: Allegany, Cattaraugus, Chautauqua, Erie, Genesee, Niagara, Orleans and Wyoming.

Buffalo Niagara benefits from its prime location in the center of an internationally significant regional community and marketplace. The region's strategic location on the Canadian-American border is within 500 miles (800 km) of 40% of the continental North American population. Our binational gateway for commerce facilitates \$82.5 billion in annual trade between the two countries.

#### WORKFORCE

- Buffalo Niagara's labor supply is comprised of more than 1.25 million employable people (age 16 and up)
- More than 112,000 students are enrolled in two- and four-year colleges, producing more than 28,000 graduates annually
- Only 15% of private-sector jobs are unionized

#### **INCENTIVES**

- START-UP NY allows businesses to operate 100% tax free for 10 years—no income tax, business, corporate, state or local taxes, sales taxes, property taxes, or franchise fees on or near academic institutions
- Fully refundable tax credits through Excelsior Jobs Program
- · Low-cost hydropower from the Niagara Power Project is available for companies planning to expand or build in Buffalo Niagara
- R&D grants through universities
- Local property tax abatements through industrial development agencies

#### **REAL ESTATE**

- Buffalo Niagara has a successful strategy in place that encourages adaptive reuse to increase our downtown core residential base, improve infrastructure and assist developers, retailers and businesses with financial tools and incentives
- Masterpieces of steel and stone built by the greatest architects of the last two centuries are being rediscovered by today's most
  progressive developers as apartments, inns, technology labs, conference centers and museums—even grain elevators are being
  converted to performance and exhibition space
- Real estate prices are significantly lower than the national average, include lease rates for Class A&B offices per square foot at \$15.97 (triple net) and industrial real estate per square foot at \$3.91 (triple net)

#### **ENTREPRENEURSHIP**

- An active entrepreneurial ecosystem led by innovators, techies, inventors and thought-leaders who care deeply for our city and volunteer their time to lead efforts such as Buffalo Startup Weekend, Startup Grind and Pitch-In events
- Challenging the ways people do business in the city's burgeoning business incubators, accelerators and co-working spaces— Z80Labs, dig, VCAMP and more
- Business competitions like 43North—the world's largest business idea competition with \$5 million in funding and support—and Student Sandbox and Bright Buffalo Niagara, are fueling startup ideas from the next generation of college students

#### QUALITY OF LIFE

- Over 1 million people gather year-round to enjoy concerts, festivals, boating, skating and more at Canalside. The waterfront site
  offers museums, vibrant shops and restaurants
- The region's renewed diversity, with people relocating here from Atlanta to Zambia, discovering outstanding new opportunities, such as the promise of a college education to qualified Buffalo Public School graduates through Say Yes Buffalo
- Thousands of acres of parks, including a spectacular system designed by the legendary Frederick Law Olmsted—miles of bike paths, forests, farms, ski slopes, two Great Lakes, the wonder of Niagara Falls, and professional and college-level football, hockey, baseball and lacrosse teams
