Valuable Incentives

GREEN, CLEAN HYDROPOWER

Low-cost hydropower has been reserved by New York State law for companies planning to build or expand in the Buffalo Niagara region. The program offers renewable hydroelectric power at an extremely affordable cost. Allocations depend on project size and scope, in particular, new job creation. This program is administered by the New York Power Authority (NYPA) and is allocated through a competitive process.

NO PERSONAL PROPERTY TAX

Property taxes in New York State are imposed on real property only. Personal property, whether tangible or intangible, is statutorily exempt from state and local taxes with New York being one of only 10 states with this offering. This "property" typically accounts for a majority of a data center's capital costs and can include servers and computers and maintenance and utility infrastructure.
